The personal health of our students is of the utmost importance in providing safe and professional healthcare. Maintaining personal health insurance is one way to protect yourself and those you care for in the clinical environment. Proof of health insurance is also required by Chamberlain's clinical partners.

Chamberlain campus pre-licensure nursing and MPAS students are required to demonstrate proof of health insurance prior to the first day of class and annually thereafter, by completing Option One or Option Two listed below. The deadline is Friday of Week 1 of your first session at Chamberlain and each new policy year thereafter.

For campus pre-licensure and MPAS students failure to provide personal health insurance documentation by the deadline may result in auto enrollment in the Aetna Injury and Sickness Plan. For a listing of current insurance rates, visit **chamberlain.edu/studentinsurance**. Your Chamberlain student account will be charged. If you need to purchase coverage, review Aetna's Student Injury and Sickness Plan summary located at **chamberlain.edu/studentinsurance** to determine which plan best meets your individual needs or visit **aetnastudenthealth.com** for additional plan information.*

* International students must have a permanent US address in order to enroll in the school-sponsored plan.

ACTION REQUIRED: All students are required to select one of the options below and follow the corresponding steps to complete your health insurance requirement. Failure to take action may result in auto enrollment in the Aetna Student Injury and Sickness Plan.

OPTION ONE:

VERIFICATION OF PERSONAL HEALTH INSURANCE

- 1. My signature acknowledges that I will not be joining the Chamberlain University-sponsored student health insurance plan because I have comparable coverage to the health benefits of the Chamberlain University plan.
- 2. I fully understand that I am legally responsible for any medical expenses incurred during my enrollment at Chamberlain University and that Chamberlain University will not be responsible for any medical expenses. It is also understood by me that if I lose my medical insurance protection, I will notify the Chamberlain Health Insurance Administrator and make necessary arrangements to join the sponsored plan.
- Complete this form in Complio and upload a copy of the front and back of your insurance card to your Complio account.

OPTION TWO:

ENROLLMENT IN AETNA'S STUDENT INJURY & SICKNESS PLAN (ENROLLMENT FORM)

- 1. Visit aetnastudenthealth.com.
- 2. Click on the Enroll Now link.
- 3. Complete the on screen enrollment instructions.
- 4. Click the **Submit** button upon completing the electronic form.
- 5. Upload a copy of the Aetna enrollment form to your Complio profile.

Your student account will be charged within the first two weeks of a new term.

Aetna will send a confirmation email within ten days of enrollment. Your insurance card is digital unless you request otherwise. To print a copy of your card or to request a permanent card via mail go to the Aetna website at aetnastudenthealth.com.
